4. **COUNTIES WITHOUT A LISTED DELEGATION OFFICE:** mail your application to the House of Representatives (address listed below).
5. Your Commission will be mailed within one week upon receipt by this office of a properly executed application. You have fifteen (15) days to hand carry your Commission to the County Clerk of Court's Office in the County of your residence located at your County Court House to register your Notary Commission.
